! Important

RemServ is offering novated lease customers an alternative charging shortcut rate of 4.2 cents per kilometre for home charging electric vehicles (EV). The rate is multiplied by the number of kilometres the electric vehicle travels during the FBT year.

The EV Home Charging Rate, or shortcut method, applies to pure EVs only (not hybrids), provided:

- You charge the car at home at least some of the time, and the cost cannot practically be separated from the cost of other household electricity usage;
- You keep records of home electricity costs incurred; and
- The calculation is based on total kilometres travelled for the FBT year and no other costs for electricity are included.

Please note: for EVs that qualify as exempt, Reportable Fringe Benefit Amounts (RFBA) are still required to be calculated. As such, the shortcut method may still be relevant for RFBA purposes, even where the car benefit itself is exempt for Fringe Benefits Tax (FBT) purposes.

- I must keep and maintain a logbook to record all my odometer readings for taxation purposes.
- I will, if required, provide one electricity bill for my residential premises in the applicable FBT year to evidence how I have incurred electricity costs.
- I will be unable to use the Tax Invoice method to claim my EV charging expenses for the duration of this FBT year.
- I will be unable to claim GST (and therefore will not receive Input Tax Credits (ITC)) associated with this reimbursement method.
