## **Purpose and Contents of this Financial Services Guide**

This Financial Services Guide (“FSG”) is prepared by EML Payment Solutions Limited ABN 30 131 436 532 (“EML”). Under its Australian Financial Services Licence, EML is authorised to provide financial services including arranging for the issue of non-cash payment facilities such as the Salary Packaging and Meal Entertainment Card (“Card”).

This FSG is issued by Remuneration Services (QLD) Pty Ltd ABN 46 093 173 089 (“RemServ”, “Representative” or “We”), an Authorised Representative of EML, Authorised Representative number 000293159. This FSG is an important document, which provides information about the financial services offered by RemServ and is designed to assist you in deciding whether to use the services offered in this FSG.

After reading this FSG, you will know:

- Who we are and how to contact us;
- What financial services can be provided to you and how these services will be provided to you;
- How we (and any other relevant persons) may be remunerated;
- Whether any relevant associations or relationships exist that may influence our general advice;
- How we maintain your personal information; and
- How to access our internal and external complaints handling arrangements.

RemServ will be acting on behalf of EML at all times when:

- RemServ arranges for the sale of and provides general financial product advice in relation to the Card; and
- RemServ promotes the Card.

EML is responsible for those financial services provided by RemServ as its Authorised Representative. EML has authorised RemServ to distribute this FSG.

### **Authorised Representatives**

EML's Representative is RemServ. RemServ is authorised by EML to arrange for the issue of, and to provide general financial product advice in relation to the Card. RemServ is not authorised to give you personal financial product advice in relation to the Card.

### **What kinds of financial products and services can RemServ provide?**

RemServ is authorised by EML to provide general financial product advice to retail and wholesale clients in relation to deposit and payment products limited to:

- Basic deposit products; and
- Non-cash payment products.

The Card is a facility for making non-cash payments (a reloadable prepaid Mastercard product) issued by EML.

This means that RemServ can:

- Arrange for the issue of the Card by EML to you;
- Provide general financial advice in relation to the Card; and
- Publish or issue certain promotional material in relation to the Card.

RemServ and its associated companies are not authorised to provide (and EML itself does not provide) personal advice about financial products. Personal advice is advice when your objectives, financial situation or needs have been or would be expected to be considered. This means that RemServ will not take your objectives, financial situation or needs into account whenever it gives general advice (in publishing or issuing promotional material) about the Card.

It is your responsibility to decide whether any general financial advice given by RemServ in its promotional material is suitable for you, or to get personal advice from a financial adviser who holds an Australian Financial Services licence or who is an Authorised Representative of an Australian Financial Services licence and who is authorised to provide personal advice.



RemServ can only provide general advice on basic deposit and non-cash payment products limited to the Card. RemServ cannot advise you on, or influence you in favour of, a financial product that is not a product that we are authorised to provide advice on.

Please be aware that EML shall not be responsible where the Representative provides any services to you, which are outside of their authorisation limits. You should therefore ask the Representative to confirm specifically that the service or product relates to deposit and non-cash payment products, prior to acting on any general advice.

### **A Product Disclosure Statement will be provided to you**

Before or at the time you are offered the Card, EML or RemServ will also provide you with, or explain how to access, a Product Disclosure Statement ("PDS") for the Card. The PDS contains information about the costs, benefits, risks and other features of the recommended financial product. You should read this information to enable you to make an informed decision prior to acquiring the Card.

### **Can I provide RemServ with instructions?**

You may provide the Authorised Representative with specific instructions by letter, email or other means (as agreed with the Authorised Representative).

### **Disclosure of any relevant conflicts of interest**

EML and RemServ are not related entities. RemServ does not have any relationships or associations that might influence them in providing you with its services.

RemServ is the provider of salary packaging arrangements for which funds are loaded onto the Card. The remuneration received by RemServ for the provision of the salary packaging arrangement is disclosed in their salary packaging contract and has no relation to the issue of the Card. Related bodies corporate of RemServ receive a split of the Card fees and charges.

### **How are RemServ and EML paid for providing financial services?**

For providing the financial services outlined in this FSG in connection with the Card, RemServ and its related bodies corporate (including McMillan Shakespeare Limited) (**RemServ Entities**) will receive a share of the Primary Cardholder Monthly Benefit Fee, as described in the table below. RemServ Entities may also receive a portion of transaction fees paid to EML, as described below.

RemServ directors and staff are remunerated by salary that includes superannuation benefits. RemServ staff may also be eligible for an annual bonus payment based on agreed performance levels.

The table below represents a summary of the fees payable by the Cardholder to EML in connection with the Card. Further information, including details of other fees, is contained in the PDS for the Card.

<b>Fees and Charges paid by the Cardholder (all fees quoted are inclusive of GST)</b>	<b>Amount payable to EML</b>
Primary Cardholder Monthly Benefit Fee	\$4.40 per Benefit per month
Partner Cardholder Monthly Benefit Fee	\$1.10 per Benefit per month

EML pays the following rebates to RemServ with reference to the fees received by EML from the Cardholders:

Fee Description (all fees quoted are inclusive of GST)	Amount payable to RemServ
Primary Cardholder Monthly Benefit Fee	\$0.19 per Benefit per month
Partner Cardholder Monthly Benefit Fee	-

By way of example, if a Primary Cardholder has both a General Living Expenses Benefit and a Meal and Entertainment Benefit, then they will be charged \$8.80 per month (\$4.40 per Benefit), with the fee apportioned in accordance with the tables above as follows:

- EML will receive \$8.42 per month; and
- Maxxia will receive \$0.38 per month.

In addition to the above, if a Cardholder elects to have a Partner Cardholder access a Benefit, there is a monthly fee of \$1.10 per Benefit accessed by the Partner Cardholder (payable solely to EML).

EML also receives interest income from Australia and New Zealand Banking Group Limited ABN 11 005 357 522 (AFSL 234527) ("ANZ") (an Authorised Deposit Taking Institution) on the total cardholder funds held in ANZ's accounts in relation to the Card. This interest income cost is not borne by Cardholders. Employees of EML do not receive, whether directly or indirectly, any fee, commission, benefit or advantage (pecuniary or otherwise) in connection with the financial services provided.

### **EML's record keeping obligations**

EML will seek to ensure that comprehensive and accurate records of all services and products and client dealings are properly maintained.

### **How can you access EML's complaints handling arrangements?**

EML is a member of the Australian Financial Complaints Authority ("AFCA"). If you have a complaint regarding the provision of financial services to you, you should take the following action:

- Speak to an Authorised Representative about your concerns, or
- Contact EML on 1300 739 889 during business hours and ask to speak to our Customer Support Staff.

If after speaking to an Authorised Representative or our Customer Support Staff, your complaint is not resolved within 21 days, please put your complaint in writing and send it to us, addressed to:

### **Professional Indemnity Insurance**

EML is required by the Corporations Act to have in place compensation arrangements designed to compensate retail clients for losses they suffer as a result of a breach by EML or its Authorised Representatives of their respective obligations relating to the provision of financial services to you.

EML maintains adequate professional indemnity insurance to cover the financial services provided by it and its Authorised Representatives. The policy maintained by EML provides coverage (in the aggregate) of up to \$10,000,000 to cover claims regarding professional indemnity, including misleading and deceptive conduct, intellectual property, defamation and fraud/dishonesty.

### **Privacy**

Your privacy is important to us and we are committed to compliance with the Privacy Act and the Australian Privacy Principles. We may disclose your personal information to external or related parties who act on our behalf in the operation of our business. Such external parties are required and committed to protecting your privacy. EML and its associates will not otherwise disclose your personal information without your consent, except as authorised or required by privacy laws. Our Privacy Policy sets out how you can access and correct information we hold about you, how you can complain about a breach by us of your privacy rights and how your complaint will be handled. ### **How does EML deal with the Anti-Money Laundering and Counter-Terrorism Financing Act?**

EML has an obligation under the Anti-Money Laundering and Counter-Terrorism Financing Act ("AML/CTF Act") to verify your identity before we can provide you with any financial services. Your Representative will let you know what documentation you will need to present to satisfy the customer identification requirements under the AML/CTF Act.

### **Do we have adequate compliance systems?**

EML remains up to date on industry compliance issues pursuant to our Australian Financial Services Licence, which requires staff and Authorised Representatives to undergo ongoing training in respect of our responsibilities to you.
