Dates should be for half yearly periods to end of March or end of August or other date if not in property for full six months. I declare for the period the remote area mortgage interest / remote area residential fuel benefits were provided, I was a current employee of the Queensland Government for the whole of the occupation period during the FBT year.

My usual place of employment is located in an eligible remote location (as determined by the ATO) for the period of my employment covered by this declaration.

I declare that the residential address that this declaration relates to is the actual address where I usually reside in an eligible remote area location for the period covered by the declaration.

I declare, where the remote area residential benefit is claimed while undertaking a temporary placement or secondment, that I did intend to return to my usual place of residence once the temporary placement or secondment was completed.

I understand that it is my responsibility to resubmit this declaration if I change address or employment location, as both my address and employment location must be deemed to be remote for taxation purposes to be eligible for this concession.

I understand that it is my responsibility to resubmit this declaration if I cease to be a current employee of Queensland Government during the FBT year (1 April to 31 March) and continue to occupy the residence for which claims have been made.

I undertake to advise my salary packaging bureau service provider of any change in my circumstances that could affect this concession. I understand that if I fail to do so that any FBT liability incurred for mortgage interest is payable by me.

I understand that I will be required to provide supporting documentation (monthly/quarterly bank statements showing mortgage interest paid). It is also understood that the 50% concession for mortgage interest for March of each FBT year cannot be claimed due to FBT reporting constraints.

I understand that I will be required to provide this declaration again in August and February of each year and that if this is not provided by the due date that the benefit will not be treated as remote area for FBT purposes.

I declare that I have not made draw-downs on the mortgage for which I am claiming the remote area concession, excepting where those draw-downs are allowable under the conditions of the 'Remote area mortgage interest loan draw-down declaration'.
